

**New York State Jefferson County Picnic  
Minutes of Annual Meeting  
February 6, 2023**

Doors opened at the Lions Club in Zephyrhills, Florida at 10:00am. Officers in attendance were as follows; President Gary K. Wilcox, Vice President Terry Baker, Treasurer David J. Schryver and Secretary John C. Doe.
